PUBLIC NOTICE IS HEREBY GIVEN THAT on Tuesday, March 9, 2021, at 7:30 p.m., the City Council of the City of Gardena will conduct a **virtual** public hearing to consider the following:

Ordinance No. 1825, to adopt Zone Code Amendment ZCA #1-21, making changes to Title 18 of the City's Zoning Code to provide for new and revised development standards specific to amenity hotels, a new use, and to provide minor clean-up language. The proposed ordinance will define amenity hotels and the mechanism for their approval. The Project also includes Resolution No. 6499 to adopt a General Plan Amendment (GPA #1-21) to amend the Land Use Plan for the General Commercial and Industrial designations. This would allow for an increased floor area ratio (FAR) of up to 2.75 in the General Commercial land use area for specific uses (self-storage facilities are already authorized to have a FAR of 2.75), and up to a 2.0 FAR in the Industrial area for specific uses. The Project would limit amenity hotels to a maximum FAR of 2.0 and only when located on arterial or major collector streets.

The Project also proposes additional amendments to the Zoning Code, which include minor clean-up language, including to uses permitted within the C-3 zone in order to more accurately reflect uses that occur and are permitted within the City. No other new permitted uses are proposed in addition to amenity hotels. The Project includes an amendment to increase the height limit for the C-3 zone to 65 feet which was inadvertently omitted during earlier code changes. The proposed ordinance reduces parking standards for amenity hotels. The City has prepared an Initial Study (EA #1-21) and determined that this change may have a significant effect on the environment, but by implementing the identified mitigation measures, the impacts would be reduced to less than significant.

On February 16, 2021, the Planning Commission reviewed the proposed amendments and recommended that the City Council: 1) adopt the IS/MND and the Mitigation Monitoring and Reporting Program; 2) amend the Land Use Plan of the General Plan; and 3) approve Ordinance No. 1825 amending the Zoning Code primarily relating to development standards for amenity hotels, with the following amendments: require a CUP for amenity hotels; do not reduce parking requirements for amenity hotels; and keep a 10-foot setback on side streets.

The City Council will be presented with two versions of the Ordinance – the one that was originally drafted and the one with the Planning Commission's recommendations. The City Council may make further changes.
