The 2021 delta aquariids might be faint to begin with because the shower favors the southern hemisphere, the delta aquariids are best seen between midnight and dawn everywhere in the world. the shooting stars we see in the sky could be from the delta aquariid or perseids. both are falling stars. however RISA'S STARS

to distinguish a delta aquariid from the perseids,, we must know our directions.

The deltas fly from the south and the perseids from the north northeast. the shooting stars emerge from "radiant points." (for the perseids, the prominent constellation perseus; for the delta aquariids, the constellation aquarius,

the water bearer. it is supposed to be an excellent year for the perseids, bright and steady with 100 shooting stars an hour, sometimes we will see shooting stars, bright fireballs, every minute. we adjust our eyes to night vision, leave our cell phones behind, lay on the ground or set out a lawn chair in the yard or on a mountaintop, gather the children and watch the light show, humanity needs more light in our dark time of the kali yuga. remember to wish upon all the
