Summary: Under existing state law, landscape projects with 500 square feet or more of new or modified landscape area are required to comply with the Model Water Efficient Landscape Ordinance (MWELO). Projects must design, install, and maintain efficient irrigation systems, utilize low water-use plantings, and set an annual water budget. This Ordinance adopts the Model Water Efficient Landscape Ordinance by reference and makes it part of Gardena's Municipal Code.
