VENUS RETROGRADES – REVIEW, RE-APPRAISE, RE-ASSESS & REPATTERN

Every two years, Venus retrogrades. This year, Venus is retrograde from December 19, 2021 to January 29, 2022. Venus retrograde is a time to assess and re-evaluate resources, money, values and relationships, their importance and their purpose.
