

LABOURS OF HERCULES –  
TWELVE STORIES & TWELVE  
SIGNS

We are presently under the fiery light of Leo, one of the twelve narratives or labors of Hercules. Each of the 12 Labors (zodiacal signs & Gates) of Hercules is a story about the Soul and the personality. Each sign describes a different relationship between the two. In Cancer, the personality ("dark light of matter") awaits the light of the Soul."
